**Office Order**

Whereas the Novel Corona virus Disease (COVID-19), a highly contagious disease declared to be a pandemic by the World Health Organization, has spread throughout the Country in the last few weeks in a rapid manner endangering the life of all citizens;

Whereas it is an established medical fact that the COVID-19 spread to a person through contact with another person who is carrying the virus (with or without symptoms) and therefore the most effective measures for prevention of all the spread of this deadly disease is curtailment of social / community contacts and quarantine of persons suspected of carrying the Corona virus;

Whereas the Government of Himachal Pradesh has notified the Himachal Pradesh Epidemic Disease (COVID-19) Regulations, 2020 to contain the spread of (COVID-19) wherein it has been mandated to keep asymptomatic persons under home/institutional quarantine and surveillance and to segregate and isolate symptomatic persons for testing and treatment as per Standard Operating protocol prescribed by the Ministry of Health & Family Welfare, Government of India.

Whereas the Chief Secretary to the Government of Himachal Pradesh vide letter No. HFW-A-A(3)1/2020 dated 14.03.2020 has directed all District Magistrates to take necessary measures for prevention of the COVID-19 in the respective jurisdictions;

Whereas DC Hamirpur vide his office order No. DCH/MA/2020-2421 dated March 16, 2020 in exercise of the power vested in him has imposed under section 144(1) of CrPS: 1973 to abort spread of Novel Corona virus disease (COVID-19) , a highly contagious disease declared to be a pandemic by the World Health Organization, has spread throughout the Country in the last few weeks in a rapid manner endangering the life of all citizens;

Whereas Secretary (HE) MHRD 2020 dated March 18,2020 has directed all ongoing examinations to be reschedule after 31.03.2020. Further, the UGC has vide letter No. F.No. 1-14/2020 (Website) dated 19.03.2020 has similarly directed that all ongoing University examinations may be rescheduled after 31<sup>st</sup> March, 2020.

In view of the above, the Competent Authority as a precautionary measures to combat COVID-19 and safety of the students and anxiety of the parents, has ordered to postpone the Minor Examination March 2020 scheduled w.e.f. March 20<sup>th</sup> - 28<sup>th</sup>, 2020. The said examination shall be rescheduled after 31<sup>st</sup> March, 2020. The students and their parents will be informed separately. Accordingly, dear students are advised to stay at their home till further information in this behalf.
